Board Member, Jake Trujillo mentioned he would like to discuss the options for parking at the General Douglas McBride Veteran's Cemetery during a funeral service. Mr. Trujillo has seen elderly family members struggling to get to the funeral service because of the restriction on who is allowed in the circle.
