## ORDINANCE NO. 896

AN ORDINANCE AMENDING SECTION 10-31 OF THE CODE OF THE CITY OF ROSWELL, NEW MEXICO 1962; PROVIDING FOR POLICE ESCORT TO CONTROL TRAFFIC FOR BUILDING MOVERS UPON REQUEST OR, WITHIN HAZARDOUS AND CONGESTED AREAS ALONG DESIGNATED ROUTES OF MOVEMENT; PROVIDING FOR PAYMENT OF REASONABLE FEES FOR SUCH ESCORT SERVICE, PAYABLE TO THE CITY CLERK; PRESCRIBING CERTAIN DETAILS INCIDENT THERETO; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT OR INCONSISTENT HEREWITH; PROVIDING FOR SEVERABILITY AND, FIXING THE EFFECTIVE DATE OF THIS ORDINANCE.

WHEREAS, it is hereby expressly declared that this ordinance is intended as a regulatory and not as a revenue measure in furtherance of public safety upon the city streets and to insure freedom of movement with minimum obstruction and elimination of hazard to life and limb within areas where escort control is indispensable in order to insure public safety.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ROSWELL, NEW MEXICO:

1. That Section 10-31 of the Code of the City of Roswell, New Mexico be, and the same hereby is amended to read as follows, to-wit:

Section 10-31. Designation of route - Police escort on request or, within areas where such escort shall be indispensable to insure public safety. - Payment.

- a. Any person intending to move a house, building or structure, or part thereof as a unit and not dismantled, from one location to another within the corporate limits in, over and by means of streets, alleys or public ways of the city, shall in the first instance make application to the Chief of Police to designate and approve a route to be used for the proposed movement calculated to afford the least obstruction to traffic and with minimal hazard to life and limb.
- b. Upon request made, or where the building or structure cannot be moved with safety, except over and through what is known to be an accident-prone street of high incidence or a traffic sensitive area inherently hazardous by reason of congestion, it shall be the duty of the Chief of Police to furnish adequate and protective escort service in and along the dangerous portions of the designated route.
- c. For such protective escort service, the person moving any such building shall pay to the City Clerk a sum of Ten(\$10) Dollars.

2. REPEALER. That all ordinances or parts of ordinances inconsistent herewith are hereby repealed to the extent only of such inconsistency. This repealer shall not be construed to revive any ordinance or parts of any ordinance heretofore repealed. 3. SEVERABILITY. That if any section, paragraph, clause or provisions of this Ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any other part of this ordinance.
