

ORDINANCE NO. 1326

AN ORDINANCE OF THE CITY OF ROSWELL, AMENDING CHAPTER 6, SECTION 6-13(1) OF THE ROSWELL CITY CODE; PROVIDING FOR SEVERABILITY; AND FIXING AN EFFECTIVE DATE.

WHEREAS the Governing Body, the City Council of Roswell, New Mexico, desires to amend the existing Section 6-13, permit and inspection fees, in order to establish new fees which will increase over a three-year period.

NOW THEREFORE BE IT ORDAINED BY THE GOVERNING BODY, THE CITY COUNCIL OF ROSWELL, NEW MEXICO, that;

Section 1. Chapter 6 of the Roswell City Code shall be amended as follows:

a. The current Section 6-13(1) shall be deleted and replaced with the following:

All fees the same as Ord 1316 (fee schedule in 1997 UBC)

Section 2. Repealer. All Ordinances or parts of Ordinances in conflict or inconsistent herewith are hereby repealed to the extent only of such conflict or inconsistency. This repealer shall not be construed to revive any Ordinance or part of any Ordinance heretofore repealed.

Section 3. Severability. If any section, paragraph, clause or provision of this Ordinance for any reason shall be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not be affected any other part of this Ordinance.


Section 4. This Ordinance shall be effective five (5) days following its publication.
