A RESOLUTION AUTHORIZING STREET
NAME CHANGES AND ADDRESSING OF SAME.

WHEREAS, currently the Roswell Industrial Air Center's commercial and industrial tenants do not have addresses and, in some cases, a street name, and

WHEREAS, the afore mentioned tenants cannot receive postal delivery for lack of addresses and, in some cases, a street name, and

WHEREAS, said tenants have difficulty in receiving freight shipments for lack of addresses and, in some cases, a street name, and

WHEREAS, the proposed loop system will aid in relief of the South Main principal arterial daily traffic count of 8,826 (which is 1,165 greater than the South Main and McGaffey average daily traffic count) and,

WHEREAS, University Avenue will move traffic to housing and the Eastern New Mexico University - Roswell, and

WHEREAS, the new proposed R.I.A.C. park, the airport terminal, flight apron, commercial and inner industrial area will be served by the southeasterly and southwesterly Earl Cummings Loop system, and

WHEREAS, access to the perimeter areas of the university may also be served by the Earl Cummings Loop, and

WHEREAS, the Airport Committee, the R.I.A.C. Street Naming Committee, the Streets and Alleys Committee find the adoption of this resolution so recommended and the re-naming of certain streets and addressing of same in the interest of the public as well as the R.I.A.C. Association, therefore,

BE IT ORDAINED by the governing body, the City Council of Roswell, New Mexico, that the R.I.A.C. streets be named or re-named as follows:
