Pull Charge:

- \$253.00 per pull PLUS
- Tonnage fee of \$46.25 per ton (Pull fee and tonnage rate, subject to change, every year on July 1st.)

Residential Roll-Offs must pay the first Pull Charge BEFORE Roll-Off is delivered

Roll-off will be pulled 1-2 business days after we are notified. NO SAME DAY PICK-UPS.

Tires, Asbestos, and Hazardous Waste such as, paint, pesticides, and oils are not allowed in the roll-off dumpster.

If Asbestos is suspected in the container: Customer will pay to have the material tested. If it tests positive for Asbestos the Customer will have to pay for the abatement of the container.

*****No additional Set-up or delivery charges*****

Loads are limited as follows:

- Open Top containers cannot be filled over the top; If they are found to be so, you will be charged a grappler fee to get the debris below the top.
- Concrete, asphalt, and bricks are limited to only 1/3 the size of the container. If it contains more than 1/3, it will exceed the maximum weight that can be hauled on city streets.
- Additional charges will be applied if load exceeds 1/3 the size of the container.

1. Invoices will be sent on the first week of the month.
2. Charge account payments are due IN FULL in 30 days. After 60 days, the account will be on a “cash only” basis. After 90 days, the account will be closed and legal action will be taken. The business WILL NOT be able to dump without paying the entire amount due. _____
3. If an account has no activity for 1 full year, the account will be closed and the person of business will need to reapply. _____
4. During holidays, please call to see if the landfill will be open.
5. During windy days, where wind is 25mph or more, the landfill will be closed. Please call ahead of time to avoid any inconvenience.

ROSWELL LANDFILL TIPPING FEES EFFECTIVE JULY 1, 2022 – JUNE 30, 2023

Residential ONLY (minimum charge) 300lbs or less: \$5.78

Mixed Loads: \$46.25 per ton

All commercial loads will be charged \$46.25 per ton of material. Residential loads, the first 300lbs will be charged a flat rate of \$5.25 plus tax. Any additional weight above the first 300lbs will be charged at \$46.25 per ton.

Heavy Loads: \$22.50 per ton

Asphalt roofing shingles, Large Tree Trunks

Clean Fill: \$17.00 per ton

Concrete, brick, asphalt, rock. MATERIALS MUST MEET CLEAN FILL STANDARDS AS APPROVED BY THE STATE OF NEW MEXICO ENVIRONMENT DEPARTMENT. Concrete with rebar is acceptable. These materials can be placed within an unlined, less expensive state approved disposal area as long as these materials are in their pure form. There can be no wood, paper, or any other biodegradable materials that can create land settlement or groundwater contamination. The less expensive disposal area allows the City of Roswell to pass disposal savings on to our customers and residents. (Otherwise, it will be charged at a mixed load rate.)

Tires (bulk): \$305.50 per ton

Tires (contaminated): \$611.75 per ton

Tires (passenger): \$5.00 per tire

Tires (truck): \$8.25 per tire

Tires (large): \$0.15 per pound

If more than 10 tires, a tire manifest is required for them (20.9.20.50 NMAC). Tires from residential locations (City or County) that are brought with household trash will be charged a minimum rate of \$5.78 for the first 300lbs, plus tonnage rate, in addition to \$5.00/passenger tire and \$8.25/truck tire.

E-Waste: \$53.75 per ton (plus \$3.25 per unit)

TV's, Printers, Hard drives

Refrigerant Units: \$53.50 per ton (plus \$15.75/evac.)

Residential/Commercial Grapple Truck Service is \$138.00 (\$144.90 tax incl.) per truckload. Grapple charge is \$66.75 (\$70.09 tax incl.) per ½ truckload. Grapple charge is \$31.50 (\$35.00 tax incl.) per anything under ¼ truck.

20 cu.yd. & 30 cu.yd. Roll-Off Containers are \$253.00 per pull, plus \$46.25 per ton. There are no delivery, set-up, or daily rental fees, but there must be a pull per 30 days, to avoid the automatic charge.
